It is followed by a mini-symposium with opinions from 6 colleagues on the questions (by M.Bates) "What about use of the LCSH over the long terms?" and "How to change the contents of the MARC bibliographic record or the MARC authorities format for subjects and how such changes would influence subject access in online catalogues". The 4th lesson brings four more answers from colleagues and a table with suggestions to the Library of Congress for improved subject access. The 5th lesson discusses - again through the answer of 6 experts - the impact of technological developments on subject access. The last lesson concentrates on the user of a subject access system with comments by two other colleagues and summarizes the series by a great number of open questions to the profession.
