Ranganathan Centenary Year Events

Russian colleague, Dr. From Eduard our SUKIASYAN we heard that a Jubilee Meeting devoted to the Ranganathan Centenary Year was to take place in Moscow on May 29, 1992. It was prepared together with the Embassy of India. Specialists, journalists, members of the Friendship were invited as well as all library, bibliographical and information organizations. A large exhibition of S.R.Ranganathan's works and of the literature about him was prepared.
