This meeting was held on Friday, April 26, 1996 with 9 members present.

Mr. MILLS presented outlines of schedules covering the three separate fields making up Volume 2 of Bliss Classification, 2nd ed. (Vol.1 is Introduction and Auxiliary sched-

The three fields are: Class 2 Generalia, Class 3 Phenomena, and Class 4/9 Prolegomena to a General Bibliographic Classification. The contents of these classes were then discussed during the meeting and documented in 7 paragraphs of the Minutes.. The next meeting, scheduled for July 12, 1996, will deal with the Earth Sciences in BC2.

20th Annual Conference. Gesellschaft für Klassifikation, Freiburg, Germany

DIMDI News

Bibliography of Editions of the International Classification of Diseases (ICD) and other Health Related Classification Systems

DIMDI, the German Institute for Medical Documentation reports that the Bibliography mentioned above (and once included in this journal) has been updated and can be obtained from DIMDI. The number of entries amounts to 300. There are printed versions and also machine-readable ones. The compilation gives priority to German language coding systems. A lot of 'older' classifications have been retained on request of several users. Owing to the requirements and the contributions of users, further titles can be added. Comments on the bibliography are welcome.

MeSH German Translation

The Thesaurus of the U.S. National Library of Medicine, known as MeSH, is now available as German language version and can be ordered as machine-readable version from DIMDI. The thesaurus contains at present more than 18.000 subject headings of medicine and related fields and is used by NLM for cataloging and indexing (e.g. MEDLINE). So far, a medical thesaurus like the MeSH was missed in the German speaking countries. DIMDI had received over several years requests for a German translation. The development of the UMLS (Unified Medical Language System) and the integration of the German MeSH in this system increased the importance of the translation efforts.
