### New Publisher of ISKO's Journal and its Series

Since Oct.1, 1996 the INDEKS Verlag has been sold to the Ergon Verlag, Würzburg, directed by Dr. H.-J. Dietrich, who has shown his interest in taking care of the distribution of ISKO's publications and thus to build up a section for Knowledge Organization in his publishing house. The representatives of the ISKO Executive Board concluded with him a contract for the next five years. The Ergon Verlag exists since 1990 and has published already some 80 books in the areas Philosophy, Theology, Education, Sociology, Politics, Law, Literature, the Arts, Ethnology, Archeology. Dr. Dietrich's special concern for ISKO's field of knowledge became visible by his personal attendance at the 4th International ISKO Conference in Washington, together with his collaborator, Dr. Christian Wacker from now on responsible for ISKO's publications. #### ISKO WG "Education and Training"

The German WG on *Hochschulausbildung in Wissensorganisation* (University Education in KO) would like to extend its membership nationally and internationally. Activities so far have concentrated on devising a program for a series of socalled pocket manuals on knowledge organization. Three of these "manuals" are in preparation and will appear in German in 1997, published by Ergon Verlag. Further possible projects are:

- A collection and analysis of current curricula in the field of Knowledge Organization
- The development of an interdisciplinary curriculum for Knowledge Organization
- The development of a case study collection on knowledge organization.

# ISKOWG "Humanities/Fiction"

At the recent Nordic, international research seminar in Copenhagen, on "Fiction, OPACs, Networks" it was found that modern information technology with its multimedia facilities such as the World Wide Web, provides quite new possibilities for integrating, organizing, sharing and studying

knowledge resources in the fields of the humanities. However, even though some common trends in research and development of knowledge organization and networking in the humanities could be found, the picture is a fragmented one in need of much more collaboration and common strategies.

The persons having organized the seminar would like therefore, to create an international forum for researchers, developers and others working within knowledge organization in the field of literature and fiction. They would like to invite ISKO members to participate in an international working group on this topic via network communication. It is planned to liaise with other scholarly communities in the field and to establish a special homepage and initiate discussion lists on the WWW.

#### Fiction, OPACs, Networks

# A Research Seminar in Copenhagen, Nov.1996

48 people participated in the Nordic international research seminar on *Fiction, OPACs, Networks*, held from 11-13 Nov. 1996 at the Royal School of Librarianship, Copenhagen. The seminar, which was chaired by *Hanne Albrechtsen*, stressed inparticular the topic of information access in the humanities, and mixed lectures on theoretical work with short presentations of ongoing experiments and projects. The seminar had two main tracks: 1) Indexing, classification, and subject searching, 2) Application of modern information technology (IT) for supporting users' access to information in the humanities.

Annelise Mark Pejtersen started with a lecture on the development of the syntactic indexing language for the Book House, based on userneeds and literary theory. Clare Begthol talked about how narrative discourse analysis can be broadened from analysis of fiction towards subject analysis in other domains, and Hans Joern Nielsen discussed howto deal with the plenitude of very different theories and paradigms in literary theorytoday in relation to indexing of fiction. Rebecca Green lectured on the role of relational structures in indexing for the humanities, and how theories on syntagmatic relationships between concepts, in particular the work on metaphors developed by George Lakoff, may be fruitfully applied for subject analysis and index string generation in humanistic domains. Michèle Hudon gave a very succinct and thoughtprovoking lecture on multilingual thesaurus construction, emphasizing how to integrate the views of different cultures in one gateway to knowledge, and stressing the importance of developing independent thesauri for each language and culture.

Roland Hjerppe lectured on infotainment, edutainment, and entertainment, and demonstrated how the hitherto separate domains: information searching, publication and mass media are converging via several types of integrated media. He warned that the opportunity of creating customizable media

and services, which is an advantage for the individual, is at the same time a disadvantage, as seen from a social and a democratic point-of-view.

Among the speakers on user participation in the creation of subject access, Pauline Rafferty Brown talked on projects in England investigating democratic indexing, i.e. how to reconcile different individual interpretations of documents into one or more public views. Ursula Schulz and Gabriela Will presented their Biicherschatz, which is an icon-based OPAC developed for children, based on the metaphor of a treasure hunt, and which has been created using a participatory design approach involving both children, teachers, and childrens' librarians, Lena Lundgren and Ringa Sandelin presented their work on end-user indexing of fiction for children in Finnish schools, and Swedisch public libraries. Paul Solomon presented his longitudinal studies of the searching behavior among children in an American elementary school, and showed some implications for OPAC developments In conclusion, the two rapporteurs, Clare Begthol and Hanne Albrechtsen, contributed with some overall perspectives that they found were prevalent in the research presented during the seminar. For instance, a new trend towards creating customized and enriched catalogues, new approaches to creating subject access, involving participatory indexing and OPAC design, a tendency towards resource sharing, in opposition to the hitherto reliance on centralized library services, etc. These trends were in particular seen in European research and development projects in subject access in the humanities. They concluded with some overall frameworks for these development trends, comprising the trend in the socalled 'postmodern era' towards focussing on the individual needs and/or domain-specificity. The new conditions for knowledge production are supported by the development of information technology and networking services, facilitating the creation of customized services, supporting peer-to-peer communication, and applicable as excellent platforms for participatory design of indexing systems and other classificatory structures. Thus, the seminar was a very fruitful forum for discussing future research approaches in indexing theory and applications, and in information system design and evaluation.

The seminar was arranged by the Scandinavian Book House Consortium and was sponsored by Nordfolk, a committee under the Nordic Council of Ministers, and by ISKO. The background paper for the seminar was the report *Subject Access to Scandinavian Fiction Literature - Indexing Methods and OPAC Development* by *Annelise Mark Pejtersen* et al. This report had been published by the Nordic Council of Ministers (TemaNord 1996:608; availablevia Ms. Margaretha Hedling, phone +45-33-960247). A proceedings volume, to be edited by Clare Begthol and Hanne Albrechtsen, comprising the full papers of the seminar, will be published in spring 1997 by The Royal School of Librarianship.
