## Copyright and Right of Publishing:

The journal and all individual articles and illustrations it contains are protected by copyright. Any re-use that is not expressly granted by copyright law requires the previous consent of the publisher. Upon acceptance of publication, the author transfers to the publisher the following rights with respect to his or her work for the duration of the legal copyright: the exclusive, worldwide and temporally unrestricted right to reproduce and distribute in physical form; the right to public reproduction and public display; the right to inclusion in databases; the right to store on electronic data storage media; the right to distribute and reproduce such storage media; and the right to make other use of the work in electronic form.
