

## FOREWORD

As always, this volume is a continuation of the research carried out as part of the seminars organized for doctoral students and other researchers at the Faculty of Law of the University of Lubumbashi, in collaboration with the Konrad Adenauer Foundation.

Unlike previous editions, this one appears in a universally peculiar context. Indeed, the pandemic linked to the coronavirus (COVID-19) has not spared the African continent in general and the Democratic Republic of Congo in particular.

MUMBA KAKUDJI Martial and MFUAMBA MULUMBA Isidore analyse the legal framework of the curfew imposed by the Congolese government in the fight against the spread of Covid-19 in the city of Lubumbashi and its practical implementation.

Finally, this volume also contains an article on the impact of state measures due to COVID-19 in Nigeria, particularly in relation to the right to life and the right to health. BONTUR LUGARD Sunday's article provides a look beyond borders.

It is clear that scientists are aware of the sensitivity of the issues involved. The quest for the consolidation of the rule of law, which has always been desired in the Democratic Republic of Congo in particular and in the African Great Lakes Region in general, is at stake!
