

## About the Contributors

**Manfred Broy** is a professor for informatics at the Technical University of Munich. His expertise is in software & systems engineering, but also in the development of the digital transformation concerning questions in techniques, politics, society, and ethics.

**Luciano Floridi** is the OII Professor of Philosophy and Ethics of Information at the University of Oxford and Professor of Sociology of Culture and Communication at the Alma Mater Studiorum University of Bologna, where he directs the Centre for Digital Ethics. World-renowned as one of the most authoritative voices of contemporary philosophy, he is considered the founding father of the philosophy of information and one of the major interpreters of the digital revolution. He is deeply engaged with policy initiatives on the socio-ethical value and implications of digital technologies and their applications, and collaborates closely on these topics with many governments and companies worldwide. He has published more than 300 works on the philosophy of information, digital ethics, the ethics of AI, and the philosophy of technology. His works have been translated into many languages, including Arabic, Chinese, Czech, Dutch, French, German, Greek, Hungarian, Italian, Japanese, Lithuanian, Persian, Polish, Portuguese, Russian and Spanish. He has been awarded many prizes and laureae honoris causa. In 2022, Sergio Mattarella, President of the Italian Republic, bestowed upon him Italy's most prestigious honour, the title of Knight of the Grand Cross of the Order of Merit, in recognition of his foundational work in philosophy.

**Markus Gabriel** holds the chair for Epistemology, Modern and Contemporary Philosophy at the University of Bonn. He is Director of the International Centre for Philosophy and of the Center for Science and Thought. Currently, he is Academic Director at The New Institute in Hamburg.

**Armin Grunwald** is a full professor of Philosophy and Ethics of Technology at Karlsruhe Institute of Technology (KIT), Germany. He has been director of the Institute for Technology Assessment and Systems Analysis at KIT (ITAS) since 1999 and Director of the Office of Technology Assessment at the German Bundestag in Berlin since 2002. His research fields include technology assessment, ethics of new technologies, digitalization, theory of sustainable development and sustainability research. Armin Grunwald is member of several advisory commissions and committees, e.g. of the German Ethics Council.

**Ruth Edith Hagengruber** holds a chair dedicated to the philosophy of Economics and Information Science at Paderborn University. She is also Director of the Center for the History of Women Philosophers and Scientists. She got her PhD with a thesis on Tommaso Campanella at Ludwig Maximilian-University Munich. From 2011-2019 she served in the Advisory Board of Technology in Society for the Technical University Munich and became Life-member of the International Association of Philosophy of Information Science in 2011. In 2020 she became elected member of the Leibniz-Sozietät der Wissenschaften zu Berlin. She serves as chief editor of the German Springer series *Frauen in Philosophie und Wissenschaft* and as co-editor of the International Springer series *Women in the History of Philosophy and Science*. With Mary Ellen Waithe, she co-edits the *Encyclopedia of Concise Concepts by Women Philosophers* and the *Journal for the History of Women Philosophers* at Brill's. With De Gruyter she edits the series *Women Philosophers World Heritage Collection*. Since 2021, she serves as secretary of the International Association of Women Philosophers. **Alexander Kriebitz** is a political scientist, who studies the overlap of international law, business ethics and international relations. His current project is a re-examination of literature on Business and Human Rights and the division of labor between states and companies in fulfilling human rights responsibilities. To this end, Dr. Alexander Kriebitz published research articles in the Business and Human Rights Journal and in the Human Rights Review.

**Christoph Lütge** is Full Professor of Business Ethics at Technical University of Munich and the Director of the TUM Institute for Ethics in Artificial Intelligence. He is Distinguished Visiting Professor of Tokyo University and has held further visiting positions at Harvard, Stockholm, Taipei and Kyoto. He has a background both in philosophy as well as business informatics. In 2007, he was awarded a Heisenberg Fellowship by the German Research Foundation.

**Raphael Max** is an economist with a philosophical background who studies political, economic and social conditions of human behavior in a modern globalized world. A particular focus of his research is the discrepancy between moral judgment and human action. Dr. Raphael Max' current project is the analysis of the normative perception of economic activities under uncertainty and moral evaluation of investment decisions.

**Catrin Misselhorn** is chair of philosophy at the University of Göttingen. She is working on the philosophy of AI, robot- and machine ethics. Her books include *Grundfragen der Maschinenethik (Basic Issues in Machine Ethics)* 2018, 5th ed. 2022 and *Künstliche Intelligenz und Empathie (Artificial Intelligence and Empathy)* 2021.
