#### Acknowledgments

This book brings together ideas I have developed over the past several decades in a variety of contexts. One of the most significant of these was my in-depth engagement with questions of empirical research, and I would like to thank the German Research Foundation (DFG) for its support of these research projects.<sup>1</sup> After completing a first version of the manuscript in the late summer of 2012, I spent a year discussing it intensively with colleagues. I had the opportunity of presenting individual chapters in the colloquia of Hubert Knoblauch and Werner Rammert, in the latter case introduced by extensive commentary from Jörg Potthast. His comments as well as Michel Hutter's detailed criticism motivated me to render more precise the sections on material technology and symbol formation.
